Subject: Recent incident involving CISF officer Ms. Kulwinder Kaur at Chandigarh Airport

We, the members of the **Hindu Raksha Dal** (an association of patriotic Indian citizens), commend and support the legally justifiable actions taken by your officer, Ms. Kulwinder Kaur, against the potential flyer and actress Ms. Kangana Ranaut, who is notorious for inciting violence against minority Hindu religious communities (e.g., Sikhs) at the behest of nations hostile to India, with the aim of creating communal unrest.

It is concerning that despite Ms. Ranaut's self-proclaimed drug use, she has never been prosecuted under the NDPS Act, nor have her narcotics suppliers been traced, suggesting potential corruption and protectionism within the Ministry of Home Affairs (MHA). Through foreign funding and such governmental corruption, the actress has now even managed to get elected to Parliament, potentially to further the anti-national agenda on behalf of foreign states.

It is well-known that under the influence of narcotics, this actress had made several, now deleted, anti-national tweets on Twitter (a Chinese propaganda channel fronted by their puppet agent, Mr. Elon Musk) advocating communal violence against minorities so as to polarise Indian citizens.

The **Hindu Raksha Dal** brotherhood has repeatedly filed complaints through all formal grievance channels to get social media channels circulating such tweets and speeches blocked by the Ministry of Home Affairs (MHA), Ministry of Electronics and Information Technology (MEITY), and Ministry of Information and Broadcasting (MIB), etc. through the ministerial nodal blocking officers. However, due to widespread corruption at the very highest levels within these ministries, no action has ever been taken despite our complaints being mischievously inquired by the Inter-Departmental Committees (IDC) *in camera*, behind our back and without our participation.

Thereafter being aggrieved we petitioned the Department of Personnel and Training (DoPT), which after considering detailed and unimpeachable evidence presented by us, had recommended (processed in F. No. 104/52/2023-AVD-IA (pt.5)) to the Appointments Committee of the Cabinet (ACC) that Mr. Ajay Kumar Bhalla (Union Home Secretary) be prosecuted for his corrupt anti-national and seditious actions. However, the file has strangely gone missing (or intercepted by foreign entities) between the DoPT and ACC.

When the Government of India itself is utterly complicit, through willful negligence, in allowing such anti-national drug-using actresses to make such tweets, enter Parliament, or board aircrafts carrying narcotics and other dangerous substances, **the vanguard security action of the CISF braveheart Ms. Kulwinder Kaur demands that she be promoted, and not punished.**

NB: In the event that any court of inquiry, etc., is initiated against CISF officer Ms. Kulwinder Kaur, we would like to present evidence in support of Ms. Kaur's utterly justifiable action(s) during those proceedings. Until then, we ask that no coercive measures be taken against her.
